You will not have exclusive use of the pool and if it becomes overcrowded, the party must leave the pool area (HOA members have priority) Commercial use of the clubhouse such as for the sale of items for monetary gain is prohibited. This usage agreement is strictly for the clubhouse interior and all parties are restricted from straying outside into the Winston Square common area. \*NO SITTING ON THE POOL/PING-PONG TABLE, NO FOOD OR DRINKS ON THE POOL/PING PONG TABLE, NO MASSE SHOTS. THE POOL TABLE IS NOT TO BE MOVED AND COULD CAUSE A \$100 MINIMUM CHARGE FOR THE RE-LEVELING OF THE TABLE.
